Define Problem / Set Aim

Problem


Multiple purchases and contracts were done and established during the setting up of NTFGH OT Complex in 2015, when planning was based on full operating capacity at 18 ORs. This has resulted in overstocking of consumables as currently, there are only 11 ORs in use.


- (1) In April 2017 March 2018 (FY2017), non-standard AU consumables that were purchased and stored in OT and not consumed resulted in a wastage of \$9,108.
- (2) As of 1 April 2018, there is still \$101,620 worth of non-standard AU consumables on old contracts that have not been consumed.





Root Cause		Potential Solutions
	1	Reduce variations of existing consumables with same function
	2	Restrict variations of new consumables with same function
	3	Get updated list of contractual agreements from MMD
No process in place to manage	4	Standardized terminologies of the description of the consumable when PRs are raised in SAP
inventory (from procurement to monitoring consumption)	5	Monitor monthly consumption of contractual agreements by items, quantity and value for early detection of unused / low usage consumables. Work with vendors to resolve where necessary.
	6	MMD to request from vendors for PO balance for items on Blanket PO and contract every 6 months to monitor consumption
	7	Guidelines to ordering consumables e.g. quantity, frequency, slow / fasting moving, lead time to delivery, quotation / quotation validity





Chart (5): Unconsumed AU Non-Standard Consumables on Old Contracts After Intervention
