

Evolution of CRC training course to adapt to COVID-19 safe management measures

INTRODUCTION

In SingHealth, CTCC conducts Clinical Research Coordinator (CRC) training courses to ensure CRCs acquire the knowledge of conducting clinical trial/research and the ethics and regulatory requirements in Singapore. Courses were conducted in a traditional face-to-face lecture setting. However in February 2020, all face-to-face training were suspended when DORSCON Orange restrictions were implemented due to the COVID-19 pandemic. To evolve with the changing environment and to meet the learning needs of new untrained CRCs, CTCC converted the CRC training course into full remote learning.

OBJECTIVES

- To convert face—to—face lectures into self-directed e learning modules (e—modules) and webinar to adapt to the safe management measures
- To ensure CRCs continue to have a platform to learn and seek clarifications despite the change in the mode of training

CHALLENGES

- Ensuring content in the e-modules are interactive and easily understood
- Ensuring modules are constantly updated with the latest regulatory requirements
- Maintaining speaker-participant interaction despite not being physically present
- Facilitating queries from CRCs
- Tracking of attendance

METHODOLOGY

- CTCC engaged the services of SingHealth Academy to develop the e-modules. To encourage better retention of information – animations, voice narrations and short quizzes were added to each e-module.
- Modules that require constant updates due to regulatory changes were not converted into e-modules but were arranged to be delivered as live lectures via a Zoom webinar.
- A live Q&A session where participants could seek advice from the speakers were added to the webinar.
- Before the actual zoom webinar, CTCC conducted dry-runs for the speakers to be acquainted with functions of Zoom.
- Participants were required to complete online quizzes and course evaluation after completing the e-modules and webinar.
- Electronic certificates of attendance were issued at the end of the online course instead of hardcopy certificates.






Figure 1: Illustration of the 3-part online CRC training course

<u>Part 1</u>: e-modules were hosted on the SingHealth eLearning Portal for 1 month and included a short quiz at the end of each module.

<u>Part 2</u>: Participants who have completed Part 1 are invited to attend the Live Lectures and 'Question & Answer' session via Zoom Webinar.

<u>Part 3</u>: After completing Parts 1 and 2, participants were given 1 week to complete the Main Quiz on SingHealth eLearning Portal and Course Evaluation Form before obtaining the E-certificate of attendance.

RESULTS AND CONCLUSION

Remote learning is one of the new ways the community moves forward in these uncertain times.

CTCC conducted the first three–part full remote learning for 'The Beginning – A CRC's Guide to Clinical Research Management' in Sep & Oct 2020, which was attended by 50 participants. Feedback gathered from the participants and speakers were positive and encouraging. The course received an overall evaluation score of 4.3 out of a maximum of 5, with a 100% pass rate for the main quiz. Participants commented that they had the flexibility to access the e–modules at their own pace, and appreciated the interaction with the speakers during the zoom webinar.

The change in the mode of training has proven to be successful. From this experience, CTCC has started the conversion of other training courses into full remote learning.
